## PAVILION RESERVATION PROCEDURE

To schedule your reservation, please come to the office and sign a contract along with a "non-refundable" \$25.00 deposit whether the grills are used or not. If given a 24-hour notice of any change in date and/or weather closures, you will be refunded. Your deposit is not used toward guest fees. **Be courteous to all your fellow members; someone else may be waiting to use the pavilions.**

Please note—our employees are hired to maintain and oversee the operations and lifesaving responsibilities of the pool.

### DIVING WELL RULES

- Our diving well is 12 feet deep. Because of this, a deep water test is required for all children under the age of 12 years.
- One person on each diving board at a time.
- Wait till the swimmer is on the ladder before going off the diving board.
- Adults are NOT permitted to "catch" small children in the water.

### DEEP WATER TEST

- Must swim 25 meters (one lap) without touching the bottom or stopping.
- Must tread in deep water for one minute.

## DIFFERENT CARD COLORS DEFINES POOL ACCESSIBILITY

You may wonder when you look at your family's membership cards why they are colored differently. Well, there's a reason! Different colors denote different levels of pool accessibility. Please note the following chart which will help you understand your card color!

### Membership Card Colors

<b>Light Blue</b>	Adult member 15 years and older
<b>Orange</b>	12-14 year olds
	*need not be accompanied by adult member
	*may bring guests of 12 years and older
	*cannot supervise Newborns-11 years old
<b>Yellow</b>	Newborns to 11 years
	*MUST be accompanied by an adult member
